Membership Terms

Renewal—Invoices for membership dues renewal are due January 1. A membership card will be sent after full payment is received.

Suspension—Members whose dues are not paid 60 days after their due date will be considered past due and all services will be suspended. Membership privileges will be reinstated at any time during the remaining months of the year after full payment is received.

Termination—Members who have not paid membership dues for the current year are terminated on December 31. When a member is terminated, membership continuity and seniority is surrendered. Membership benefits will not be reinstated, but terminated members can apply for a new membership.

Security Management—Your annual membership fee entitles you to receive an electronic version of Security Management magazine. If you would like to receive the copy of the magazine by mail, you must pay the \$195 membership fee.

Deductibility—ASIS membership dues (and dues paid to its chapters-if applicable) may be deducted as an ordinary business expense for members residing in the United States.
